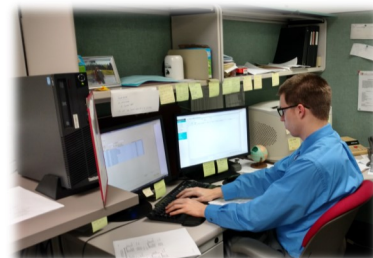

This includes following “eligible and ineligible” expenses related to the operation of each home that determine reimbursement rates. They are also tasked with each resident’s guardianship account activity. Along with that and their continued growth and increased funding audit regulations was the driving force in implementing MIP Fund Accounting in 2001.

TIMELY ALLOCATIONS

Ramirez identified allocations and payroll import as two key time savers as a result of MIP. "In the past, allocations were done once a year; now, with the MIP Allocation Module, we allocate costs monthly and have timely and accurate financials as a result" reports Ramirez.

PAYROLL IMPORT SAVES HOURS OF REKEYING

CRS prefers to outsource payroll, but rekeying into an accounting system was time consuming. "Wessel worked with our team and now we simply import the payroll data into MIP – which saves hours of staff time each pay period".

FIXED ASSETS

The Fixed Asset module of MIP allows CRS to track their fixed assets by residential home – something that was managed prior by their outside accountants. Now they maintain an accurate and timely record of each home's assets and retrieving that information at any time is at their fingertips
